POSITION PURPOSE: Responsible for pump tests, video and developing wells.

ESSENTIAL DUTIES & RESPONSIBILITIES:

Primary duties on the well rehabilitation side include but not limited to:

- Video wells – Operating the company video van to video wells then download results back at the office. Inform the relevant sales team along with supervisor of results. Maintain all equipment in a serviceable condition.
- Carry out pump testing – Provide accurate pump tests then report findings to supervisor.
- Airshocking of wells – Work on the Airshock tool to rehab wells
- Run pump developing engine – Develop wells, maintaining records as you go.
- Maintain a clean & operational vehicle at all times. Keep the vehicle stocked of the necessary inventory.

MANAGEMENT RESPONSIBILITIES: Nil – maintain clear communication with fellow employees & customers.

QUALIFICATION REQUIREMENTS: To hold this position successfully, an individual must be able to perform each essential duty satisfactorily.

EDUCATION AND/OR EXPERIENCE: Minimum requirement for post is a GED with an emphasis on basic mathematics.

LANGUAGE SKILLS: Ability to read, analyze and implement documented instructions, tasks & provide relevant reports when requested.

REASONING ABILITY: Ability to define problems, collect pertinent facts & draw valid conclusion to resolve situation.
